SYNDICATE BANK OFFICERS' ASSOCIATION (SBOA) BECOMES CANARA BANK OFFICERS FEDERATION (CBOF) - GETS CHECK OFF FACILITY IN HRMS

We had vide our circular no. 4/2021 dated 14.06.2021 informed our members about the decision of the General Body of Syndicate Bank Officers' Association to rescind the proposal of amalgamation of Syndicate Bank Officers' Association with Canara Bank Officers' Association and instead to change its name to Canara Bank Officers' Federation and also to amend the bye-laws of Syndicate Bank Officers' Association as proposed in our Notice vide our Circular no.2/2021 dated 09.06.2021.

We are now pleased to inform the members that the Competent Authority has approved the change of name of Syndicate Bank Officers' Association as Canara Bank Officers Federation and also the amendments to the bye-laws as passed by the General Body. Accordingly, Syndicate Bank Officers' Association (SBOA) will now onwards be known as Canara Bank Officers Federation (CBOF).

We further wish to inform the members that subsequent to the change of name of our Association, we requested our beloved Bank to continue the check off facility, which was granted to us by eSyndicate Bank, in our new name i.e. Canara Bank Officers Federation (CBOF). We are pleased to inform the members that our beloved Bank has considered our request favourably and has granted check off facility to us in the name of Canara Bank Officers Federation (Code : OFFFED) and window for the same is made available in HRMS. We thank the Management for the same and assure that CBOF will always strive to foster the growth and development of our beloved Bank.

While we have requested the Management to transfer our members back to us from backend and deduct monthly subscription at Rs.160/- from them and credit to our account, we advise our members to register their check off mandate in favour of Canara Bank Officers Federation (Code OFFFED) in HRMS without waiting for transfer of membership from backend. Members may be aware that at present their subscription is credited to the account of CBOA and hence it is necessary to register their check off mandate in favour of CBOF so that their subscription is credited to our account. Since our members, whose membership is merged with the membership of CBOA at our request from back end, are already members of Syndicate Bank Officers' Association, they need not submit the membership form again, though the name of the union is changed. It is enough to register the check off mandate in HRMS.

We further wish to inform all the officers of Canara Bank that the membership of Canara Bank Officers Federation is not restricted only to the members of Syndicate Bank Officers' Association, but is open to all the officers of Canara Bank. We invite all the officers of Canara Bank to kindly go through the track record of Syndicate Bank Officers' Association in eSyndicate Bank, in taking up the issues of the officers and getting them resolved while simultaneously working to foster the growth and development of the Bank, and join Canara Bank Officers Federation (CBOF).

By strengthening CBOF you will be strengthening our beloved Bank simultaneously strengthening yourself.


